

## **ADDITIONAL POOL RULES AMENDED TUESDAY, November 6, 2020**

We believe that these additional rules will help with the safety of all and we are expecting compliance from all who use the Pool and Recreation area. In keeping with County, State, Federal, and the CDC guidelines, we will be implementing the following additional rules:

- Use of the Recreation Area and pool will be restricted to non-quarantined residents of WFV and their non-quarantined family members only. Other guests/visitors will not be permitted.
- All individuals wishing to use the pool will do so on a first come, first served basis, with a limit of four people allowed in the pool at any given time.
- All individuals wishing to use the hot tub will do so on a first come, first served basis, with a limit of one person allowed in the hot tub at any given time. The only exception of this will be family members residing in the same unit may use the hot tub together. A face mask must be worn when using the hot tub. We are asking users to limit themselves to a maximum of 30 minutes at a time in the hot tub if others are waiting to use it.
- BBQ's can be used provided that social distancing is adhered to. Due to the fact that our BBQ's are located next to each other, two people are not permitted to grill standing next to each other at the same time.
- Face masks are to be worn at **ALL** times by all persons once entering the gate to the Pool and Recreation Area with the only exception being if you are swimming under water. If you are wading in the pool a face mask is required.
- Only one person is permitted in the Fitness Center at any given time. The only exception of this will be family members residing in the same unit may use the Fitness Center together. Use of the Fitness Center shall be limited to 1 hour per person in order to provide other users with an opportunity to use the facility.
- There must be a waiting period of 15 minutes between users so that facility remains empty for that period before the next user enters.
- All equipment and "touch points" in the Fitness Center must be sanitized at the end of the exercise period by the user before they leave the facility.
- We will use our regular hours of operation, from 8:00 AM- 10:00 PM. It will require people to comply with the rules and be on the "honor system." We are asking swimmers to limit themselves to an hour at a time in the pool, if others are waiting to swim.
- All individuals must bring their own disinfecting wipes and/or adequate disinfectant to wipe down all surfaces touched/contacted. Please come prepared and pay special attention to the pool entrance gate handles, bathroom door handles, pool handrails, the outdoor shower knob, bathroom soap dispensers, toilet flush handles and any other surfaces that you may come in contact with.
- All individuals **MUST** shower before entering the pool. The showers in the bathrooms will be closed, so the outdoor shower must be used. Medium to long hair must be put up with a hair tie (rubber band type), hair claw, or a swimming cap may be worn.
- Social Distancing is to be practiced at **ALL** times in the Pool and Recreation Area.
- Four loungers and **two chairs shall be provided** which will be spaced 6 feet apart. The loungers/chairs may not be moved from their designated positions on the pool deck or on to the grass. The only exception of this will be family members residing in the same unit may move loungers/chairs from their designated positions on the pool deck so that they can be next to each other. The loungers/chairs will need to be moved back to their designated positions by these users prior to leaving the area. Face masks are to be worn at **ALL** times by all persons when using the loungers/chairs. Users are not permitted to bring their own beach chairs or furniture into the Recreation Area.
- Please note that the Site Managers office is not open at this time. Please communicate with him via email (preferred) or phone as has been done since late March.
